1. PROJECT OVERVIEW

EDF is pleased to present the **Micro-Enterprise Support Project (MESP)** Year 5 Quarter 4 Report in accordance with **USAID Cooperative Agreement Number**: **AID-112-A-12-00001**. This Project activities report completed during Q4 – February 1– April 25, 2017.

The MESP began operations in May 2012 and mostly builds on the work of institutional Development of EDF, preparing detailed working plans for first and second years, development and signing agreements with five project partners: Economic Research Center, Support for Economic Initiatives Public Union, Small and Medium Enterprise Development Support Center, Bridge to the Future Youth Public Union (Ganja city), and World of Carpet Association (Guba city).

The MESP objectives are:

- Improved dialogue and interaction between the state and civil society on the issues of the development of micro and small businesses in the country;
- Improved legislative and institutional framework for enabling environment for MSEs;
- Practical assistance to micro and small businesses, in particular for women family businesses to improve their viability and successful development.

Formally, the Project is divided into the seven interconnected and interdependent components:

- 1) Study of the problems of MSE and policy recommendations;
- 2) Legislative framework on business enabling environment;
- 3) Institutional framework on business enabling environment;
- 4) Mechanism of the protection of MSE from bureaucratic arbitrariness;
- 5) Increased competitiveness and efficiency of MSE;
- 6) Enhanced women's family business;
- 7) Access to financial sources for MSE.

In the reporting quarter, a number of activities have been performed in 2nd, 3rd, 5th and 6th components. Completed work on these components is described in this report.

- 1. Two Round Tables on "Decriminalization of Business" and "The influence of the situation in the banking sector on SMEs and expectations";

2. PROJECT ACCOMPLISHMENTS IN YEAR 5 Q4

The goal of MESP is to create a favorable business environment for the growth of small businesses in Azerbaijan.

In order to reach the goal of the project EDF and its partner organizations fulfill three major objectives:

- 1. Improved dialogue and interaction between the state and civil society on the issues of the development of micro and small businesses in the country;
- 2. Improved legislative and institutional framework for enabling environment for MSEs;
- 3. Practical assistance to micro and small businesses, in particular for women family businesses to improve their viability and successful development.

Accomplishments of the MESP during the 20th quarter:

Objective 1. Improved dialogue and interaction between the state and civil society on the issues of the development of micro and small businesses in the country.

In accordance with the First Objective of the MESP, during the 20th quarter, following activies were carried out:

- I. Workshop on Development of Women's Business and Women Business Associations was held.
- II. Training on "Establishment and development of Women Entrepreneur Associations" for business associations was held.
- III. Round Tables on the theme of Round Table on the theme of "The influence of the situation in the banking sector on SMEs and expectations" and "Decriminalization of Business were held".
- IV. Economic Forum Internet TV Programs were broadcasted on the issues:
 - 1) The strategic road map for the development of small entrepreneurship: current situation
 - 2) What form of subsidies does the agricultural sector need?
 - 3) Problems of Entrepreneurship in Azerbaijan
 - 4) Open Government Partnership
 - 5) Characteristics of leasing business. Problems and ways to solve them

Objective 2. Improved legislative and institutional framework for enabling environment for MSEs.

Objective 3: Practical assistance to micro and small businesses, in particular for women family businesses to improve their viability and successful development.

In accordance with the Third Objective of the MESP, during the 20th quarter, support for women's business was discussed at the:

- 1. Training on "Establishment and development of Women Entrepreneur Associations" for business associations;
- 2. Training for women who want to become entrepreneurs;
- 3. 4 women's businesses were established / developed in Guba district;
- 4. Workshop on Development of Women's Business and Women Business Associations
- 5. Forum with young entrepreneurs.

3. DETAILED ACTIVITIES

3.1. Round Tables

3.1.1. Round Table on the theme of "Decriminalization of Business"

On March 6, 2017, Entrepreneurship Development Foundation and National Confederation of Entrepreneurs "Employers" Organization of Azerbaijan Republic held a round table on "Decriminalization of Business". Lawyers, representatives of public unions and the Confederation attended the round table.

3.1.2. Round Table on the theme of "The influence of the situation in the banking sector on SMEs and expectations"

On April 12, 2017, Entrepreneurship Development Foundation and Support for Economic Initatives Public Union held a round table on "The influence of the situation in the banking sector on SMEs and expectations". Representatives of banks, various companies, associations attended the round table.



Samir Aliyev, an expert of YSUH, made a presentation at the round table. At the beginning of the speech, he reminded participants of the main macroeconomic indicators for the past 5 years, and then he outlined the current situation in the banking sector of the country. After that, the expert described the impact of the

crisis situation in the banking sector on SMEs. Samir Aliyev assured his speech of a number of recommendations on improving the access of SMEs to financial resources. Among these recommendations are the creation of a credit insurance fund, the adoption of a law on venture funds, the development of mechanisms for the pledge of movable property, the development of a strategy for the dedollarization of the economy, the creation of sectoral banks (agrarian, investment, export) and other recommendations.

3.2. Trainings

3.2.1. Training on "Establishment and development of Women Entrepreneur Associations" for business associations

On March 15-16, 2017 in VEGO hotel in Ganja the training on "Establishment and development of Women Entrepreneur Associations" was held for business associations by "Bridge to the future" Youth Public Union (BF PU - Ganja) and the Entrepreneurship Development Foundation in the framework of the Micro Enterprise Support Project.

Representatives of business associations and representatives of various social organizations attended the training.

Sabit Bagirov – President of the Entrepreneurship Development Foundation made opening remarks at the training. Executive Director of Azerbaijan Microfinance Association Jala Hajiyeva conducted a training on "Establishment of Associations". After the brake the event was continued with the training on "Strategic planning"





On the next day Jale Hajiyeva continued the training on "Methods to increase members in associations" and "Establishment and development of relationships".

After the lunch Galib Bayramov, Head of Economic Research Center conducted a training on "Ways to establish a dialogue between the state and private business".

At the end of the training discussions were held around training topics and the participants were informed about future training programs.

3.2.2. Training for women who want to become entrepreneurs

On April 8-9, 2017, Entrepreneurship Development Foundation and Young Business Factory held two days training in Baku for women who want to become entrepreneurs. The purpose of the training is to teach participants the basics of entrepreneurship and, also, to help them develop their business ideas. In total, 21 girls took part in the training. Trainers were Azad Rahimov and Elkhan Mammadov. CVs of both coaches are attached in Annex 3, 4.







The training program included the following issues:

- Basic concepts of entrepreneurship and, in particular, small business;
- Legal forms of entrepreneurship. Legal responsibility;

- Steps to create your business;
- Registration of small business;
- What is a business idea? Where does the business idea come from?
- Business plan. Its structure and elements;
- Marketing;
- Monthly sales plan;
- Human resources;
- Financial plan;
- Taxes paid by small businesses. Tax return. Statistical reports;
- Discussion of participants' business ideas.

At the end of the training, participants were given certificates.

3.3. Workshop on Development of Women's Business and Women Business Associations

On April 18, 2017, workshop on Development of Women's Business and Women Business Associations was held by the Entrepreneurship Development Foundation in Baku, Park Inn Hotel. Women entrepreneurs from Baku and regions, chairwomen of women business associations, representatives of ministries and experts attended the workshop.

Sabit Bagirov – the President of Entrepreneurship Development Foundation made an opening speech. He emphasized the important of women's entrepreneurship in Azerbaijan.

Mr. Randall Olson, Director of the Office of Governance and Economic Resilience, USAID/Azerbaijan made his remarks on importance of Development of women business for Azerbaijan. He spoke about the importance of women's entrepreneurship for the country's economy.













At the first session, Dr. Antal Szabo, UN ret. Regional Adviser, Scientific Director of ERENET, made a presentation on the state policy of the European countries on development of the women-family business. The speaker informed about Beijing Platform for Action and its strategic objectives adopted at the Fourth World Conference on Women, Beijing 1995. Mr. Szabo, in his speech, spoke about the results of women's entrepreneurship and noted that women make up around 40% of the global workforce. Then, in his presentation, he informed about the European Business Initiative, and Women's Entrepreneurship Index. The speaker spoke about world experience in women's entrepreneurship and cited world's best countries for women's entrepreneurship, top 3 countries are the US, Australia and the United Kingdom.

At the second session, Dr. Antal Szabo, made a presentation on the EU programs and directives for supporting the development of women's business.

The speaker, in his speech, spoke about the experience of European countries in women's entrepreneurship such as Austria, Bulgaria, Finland, Germany. Then he informed about the Business Model Canvas, the European Network for the promotion of women's entrepreneurship, and the European Network of Female Entrepreneurship Ambassadors. Later, Dr. Antal Szabo, cited successful women entrepreneurs from Azerbaijan and around the world and their success stories. He noted that there are women in the world who were able to manage the business, and family at the same time.

After lunch, Mrs. Daiva Jonuskiene, Siauliai Chamber of Commerce, Industry and Crafts, made a presentation on Women's business associations in the Baltic countries. Her presentation was interactive, women entrepreneur actively participated in discussions. Mrs. Daiva, spoke about European Economic and Social Committee position and quotas. Speaking about Lithuanian experience, she said that, today in Lithuania there are 39 % of women at CEO positions. She said that for achieving successful results, public–private partnership is very important, and the government should take advantage of all the institutions.

At the second part of the presentation, Mrs. Daiva, spoke about the development of women's networks and Lithuanian Business Women network creation experience, and talked about the importance of networking in the field of women's entrepreneurship.



DR. ANTAL SZABÓ



Dr. Antal Szabó, UN retired Regional Adviser, Scientific Director of the ERENET working at the United Nations Economic Commission for Europe (UNECE) in Geneva.

- He graduated in 1965 from the University for Oil and Gas (Moscow), receiving a Masters of Science in Process Control and Instrumentation Engineering.
- In 1971 he received a Master of Science in Semiconductor Electronics from the Budapest Technical University.
- In 1975 he became Doctor of Science (Ph.D.) in Automation Devices at the Budapest Technical University
- He holds a Diploma in Management Studies from the Buckinghamshire College (UK).
- In 1995 he became a Member of the Hungarian Engineering Academy.

From September1994 he became a staff member of the United Nations Economic Commission for Europe, as Regional Adviser on Indstry and Technology and later on Entrepreneurship and SMEs. He retired from the UNECE on 1 July 2005. However, he became a Consultant on Entrepreneurship and SMEs of the same organization.

The UNECE's **Programme for the Development of Small- and Medium-sized Enterprises** (SMEs) in Countries in Transition and Emerging Market Economies (further as CITs) aims at accelerating and assisting the creation of a sustainable supportive business environment for SMEs (policy and legislative framework and supportative infrastructural institutional and organisational elements like to establish business support institutions, business incubation, provide access to financial resources though non/conventional financial intermediaries, promote access to technology and innovation, improve competitiveness through quality orientation, develop responsible and social entrepreneurship, ensure equal opportunities for women entrepreneurs and youth, etc.).

Dr. Antal Szabó provides technical assistant to the UNECE's Governments in formulating their national SME policies and support programme, collect statistics on SMEs, organizes forums on best practice on national policies and programmes of promotion of entrepreneurship and SMEs in the transition economies as well as expert meetings on benchmarking of various aspects of supporting and operating SMEs. He drafted a policy paper entitled "Declaration on the SMEs at the Dawn of the 21st Century", which has been adopted within the framework of the CEI and BSEC and the adaptation in CIS is in progress. During the last eleven years of his assignment he visited nearly all CITs and many other advances market economies. He created a large virtual network of SME national focal points in the UNECE region. He intensively assists in developing entrepreneurship and SME sector in the Caucasian transition economies and organized several workshop and study tour for the representatives of Armenia, Azerbaijan and Georgia.

Dr. Antal Szabó maintains a special web-site on the SME Development in the UNECE region (see at http://www.unece.org/indust/sme/ece-sme.htm). He created the UNECE Teams

of Specialists on Quality Management Systems and on Youth Entrepreneurship.
