# 1. PROJECT OVERVIEW

EDF is pleased to present the Women's Entrepreneurship Development Component of the Micro-Enterprise Support Project (MESP) Year 2 Report in accordance with InterimWorking Plans for January 1 - December 31, 2020. USAID Cooperative Agreement Number: AID-112-A-12-00001.

According to these Interims Plans, the planned activity can be combined into the following components:

- 1. Building capacity of key local partners to better serve and improve enabling environment for women entrepreneurs:
  - a. Survey among 500 business women in 10 regions to inform about needs and barriers;
  - b. Advocacy and policy recommendations to alleviate most common administrative barriers;
  - c. Gender focal point training;
  - d. Access to funding (work with financial intuitions);
  - e. Conducting conferences on women entrepreneurship issues.
- 2. Increasing women economic participation through capacity building, vocational trainings and new business start-ups:
  - a. Leadership trainings;
  - b. Entrepreneurial skills training;
  - c. Mentorship;
  - d. Business start-ups
- 3. Improving access to markets for women entrepreneurs:
  - a. To improve access to useful information through cellphone applications and EDF website;
  - b. Promote women networking platforms to increase women-entrepreneurs awareness on ongoing initiatives supporting women owned businesses and other topics.

In the reporting Year, a number of activities have been completed described in this report.

# Outputs in the reporting year:

- 1) Overall, 78 women-owned businesses were established and developed in 43 geografical points of Azerbaijan during the implementation of the project. Necessary equipment was purchased for them;

- 7) 26 Weekly and 3 Monthly newsletters on COVID-19 pandemic were published during the year;
- 8) 13 entrepreneurship courses on various entrepreneurial issues were recorded and broadcasted on EDF YouTube channel;
- 9) 11 Lesson videos on various aspects of taxation;
- 10)4 Zoom video conferences were held with the participation of economic experts on impact of the pandemic on business and e-commerce and electronic payments;
- 11) New version of EDF websites;
- 12) Success stories of 5 women's business were published on media;

- 2) 11 Lesson videos on various aspects of taxation;
- Four Zoom video conferences were held with the participation of economic experts on impact of the pandemic on business and e-commerce and electronic payments;
- 4) 26 Weekly and 3 Monthly newsletters on COVID-19 pandemic were published during the year.

# 3. DETAILED ACTIVITIES

### 3.1. ESTABLISHMENT OF WOMEN-OWNED BUSINESSES

During the reporting year, 54 new women-owned businesses were established in Baku and regions of Azerbaijan. Total number of newly established businesses reached 78. All of them have been provided with the necessary equipment and already successfully started their businesses. During the visit, Acts of Acceptance related to the equipment provided to women entrepreneurs within the project were signed, and the use of the equipment was monitored. A survey was conducted among women entrepreneurs on the current state of businesses during the pandemic (questionnaire attached). Necessary information was obtained on the current state of women-owned businesses, the impact

of the pandemic on their businesses, and the increase in family incomes following USAID support.







# 3.2.2. Monitoring in Goychay and Shamakhi

Two startups continue to operate in Goychay: 1) Sakina Mursalova - making various gift items; 2) Nargiz Samadova - beaded embroidery of various paintings. New products of these startups were presented to the monitoring group. According to them, they continue to work. Sakina Mursalova constantly has new orders and her business did not suffer during the pandemic. The situation is somewhat worse for Nargiz Samadova, since no exhibitions are currently held due to the COVID-19 pandemic. During the visit, Nargiz Samadova received new types of equipment and accessories.

In Shamakhi, the monitoring group visited the beauty salon of Solmaz Alasgarova. At the beginning of the year, the salon was equipped with the necessary equipment for hair care within the project. Now the activities of the salon have been expanded and they also provide nail care services. During the visit, she was given a number of accessories for this new activity. Overall, the startup suffered from the COVID-19 pandemic.

# 3.11. IDENTIFYING THE SITUATION WITH WOMEN-OWNED BUSINESSES DURING PANDEMIC

EDF contacted women entrepreneurs to identify the situation with their businesses during pandemic.

During June, due to mitigation of quarantine, 57 startups out of 62 startups resumed activities. The others have not yet resumed their work because of 3 reasons:

- a) Fear of contracting the virus. The number of visitors significantly reduced in beauty salons. Due to the ban on wedding, customers significantly decreased in beauty salons and tailoring sectors;
- b) Due to ban on trade centers and shops, it is impossible to purchase necessary equipment;
- c) Fitness center could not resume activities due to ban on their activities.

During July, due to the tightening of the special quarantine regime again, only 22 women-owned out of 62 startups fully resumed their activities. 30 startups partially resumed their activities. These are 11 seamstresses from Guba, 2 seamstresses in Khachmaz, 3 seamstresses in Sumgait, 5 seamstresses in Baku, 3 seamstresses in Gakh, 1 confectioner in Ganja, 1 confectioner in Baku, 1 confectioner in Gakh, 2 start-ups for needlework in Goychay.

Due to the quarantine, 10 startups had to suspend their activities again: 1 fitness center in Khachmaz, 1 game center in Ganja, 1 psychology center, 1 beauty salon in Ganja, 3 startups in 1 beauty salon in Khachmaz, 1 center for the creative development of children, 1 aquapilling center in Mingechevir, 1 carpet weaver in Goychay.

### 3.14. ANALYSIS OF SME SUPPORT PROGRAMS DURING PANDEMIC

EDF conducted the analysis of SME support programs in 11 countries businesses during pandemic. Analysis focuses on how SMEs are affected by the current COVID-19 pandemic in the world, researches world countries' responses to foster SME resilience. The analysis covers 11 countries' experience: United States, Germany, United Kingdom, France, Turkey, Russia, Ukraine, Poland, Belarus, Georgia, Moldova.

The coronavirus pandemic has caused numerous deaths worldwide, including deep economic crises. The IMF's World Economic Review, released on April 14, predicts that global GDP will shrink by 3% in 2020, with the risk of further declines<sup>1</sup>. A number of banks and institutions also forecast a negative trend for GDP in 2020<sup>2</sup>. Therefore, many countries have introduced SME specific policy measures<sup>3</sup>:

- Several countries (USA, Germany, Turkey) have introduced measures related to working time shortening, temporary lay-off and sick leave, some targeted directly at SMEs. Similarly, governments provide wage and income support for employees temporarily laid off, or for companies to safeguard employment. In many cases, countries have introduced measures specifically focused on the selfemployed;
- In order to ease liquidity constraints, many countries (USA, Germany, United Kingdom, France, Turkey, Poland, Belarus, Georgia, Moldova) have introduced measures towards the deferral of tax, social security payments, debt payments and rent and utility payments. In some cases, tax relief or a moratorium on debt repayments have been implemented. Also, some countries are taking measures regarding procedures for public procurement and late payments;
- Several countries (USA, Germany, United Kingdom, France, Turkey, Poland, Georgia) have introduced, extended or simplified the provision of loan guarantees, to enable commercial banks to expand lending to SMEs;
- In some cases, countries (USA, United Kingdom, France, Turkey) have stepped up direct lending to SMEs through public institutions;
- Several countries (USA, Germany, United Kingdom, France, Turkey, Poland, Russia, Georgia, Moldova) are providing grants and subsidies to SMEs and other companies to bridge the drop in revenues;
- Countries increasingly use non-banking financial support intermediaries in their policy support mix;
- Increasingly, countries are putting in place structural policies to help SMEs adopt

## Annex 2. MONITORING OF NEWLY ESTABLISHED WOMEN-OWNED BUSINESSES IN BAKU DURING PANDEMIC

August 18-19, 2020. Baku


On August 18-19, 2020, the EDF's staff and USAID representative Ulker Akberova visited 6 women-owned businesses in Baku to monitor women's businesses established within the framework of "Support to Women's Entrepreneurship Development in Azerbaijan" Project. During the visit, Acts of Acceptance related to the equipment provided to women entrepreneurs within the project were signed, and the use of the equipment was monitored. A survey was conducted among women entrepreneurs on the current state of businesses during the pandemic (questionnaire attached). Necessary information was obtained on the current state of women-owned businesses, the impact of the pandemic on their businesses, and the increase in family incomes following USAID support.

### 1. Ruhangiz Aliyeva, a tailor engaged in the production of national costumes

Ruhangiz Aliyeva and Alida Rahimova established their business activities at the integrated boarding school No. 11 in Bilgah settlement of Sabunchu district. The place where the business is established is spacious and tidy and has all the opportunities for business activities.

Ms. Ruhangiz said that she continued her business activities during the pandemic and still continues to work. She noted that orders did not decrease during the pandemic, and she thinks that if schools open, orders will increase. Currently, she has an order of 10 national costumes. Ms. Ruhangiz noted that the support provided by USAID has led to an increase in family income of about 15%. She said her regular customers were mainly schools and kindergartens. She said she did not use social networks to organize sales. Ruhangiz Aliyeva was provided with the following equipment and supplies within the MESP:
