#### **Sabit BAGIROV**



Mr. Bagirov graduated from Azerbaijan Oil Academy in 1971. In 1977-1992 he worked in AZNEFTKIMYAMASH Concern. He worked as State Advisor on strategic programs, and as President of the SOCAR in 1992-1993. He worked as a department head of the Higher Attestation Commission under the President of the Republic of Azerbaijan in 1993-1994. Mr. Bagirov has been holding managerial posts at the Entrepreneurship Development Foundation since 1995. He worked as a consultant on the Caspian energy projects for various companies between 1994 and 2004. He was a consultant for the World Bank on Azerbaijan energy projects from 1998 to 2004. He has been a founder and member of several international and national civil society associations, and served in their governing bodies. Mr. Bagirov holds Ph.D in technics.

#### **Vahid AHMADOV**



Mr. Ahmadov studied at Azerbaijan Polytechnic Institute in 1965-1971. He graduated from Bonn Management Institute of Germany and was awarded with international diploma on management - economist in 1989-1992.

During his professional activity, Mr. Ahmadov worked in various positions at Schmidt (present-day Sattarkhan) Machinery Plant (1967-1977), Baku Radio Factory (1977), Baku Machine-tool Manufacturing Union (1981-1983), Machine-Building Plant named after Baku Worker (1983-1986), Keshla Machine-building Plant (1986) and "Bakneftmash" Production Union (1989).

In 1992-1993, Mr. Ahmadov served as Deputy Prime Minister and First Deputy Prime Minister of the Republic of Azerbaijan. He was a member of the Azerbaijani Supreme Soviet (1990-1995), and was elected to the 3rd and 4th National Assembly of the Republic of Azerbaijan from Quba Constituency No. 52, and has been a member of the Standing Committee on Economic Policy of the National Assembly since 2010. Mr. Ahmadov holds Ph.D in

technics and is the author of nearly 300 scientific articles. He is married and has two children.

#### **Federico BERNÀ**



Mr Federico Bernà holds a degree in "Tropical and Subtropical Agriculture" from the University of Florence/Italy. Having worked in Brussels and for five different European Union Delegations around the globe (Colombia, Nicaragua, Georgia, Jamaica, and Azerbaijan), he has 19 years of professional experience working in international cooperation programmes, and 14 years of professional experience working in third countries, managing development cooperation projects for the EU. Since September 2011, he is the Head of the Cooperation Section at the EU Delegation in Baku.

#### **Faig NAJAFOV**



Faig NAJAFOV graduated from the faculty of history at Baku State University in 1997, international law at Baku State University in 2003 and finance and credit at Azerbaijan State Economic University in 2006.

He worked as worker at the United Industrial Construction Enterprise of Azerbaijan Water Construction Concern in 1993-1997 and a police officer in the Khatai District Police Department of the Ministry of Internal Affairs in 1997-2000. He worked as a lawyer, head lawyer, senior consultant, head of sector and deputy head of department at the Ministry of Finance in 2000-2007.

Since July 2007 he has been heading the Department of Law and Civil Service of the Chamber of Accounts of the Republic of Azerbaijan. In 2011, Mr. Najafov was awarded with "Medal for Distinction in Public Service" by the

President of the Republic of Azerbaijan. He is married and has one child.

#### **Olaf HEIDELBACH**



Dr. Olaf Heidelberg studied Agricultural Economics and Development Studies at the Universities of Hohenheim/Germany and Ås/Norway. In 2007 he defended his doctoral thesis on innovative risk management instruments in Kazakhstan's agricultural sector at the Martin Luther University in Halle (Saale)/Germany. Between 2007 and 2012 he has been working at the EU Delegation to the Kyrgyz Republic and has managed numerous projects and sector policy support programmes in Central Asia on democratisation and good governance, education, and rural development involving civil society and government institutions. #### **Vuqar BAYRAMOV**

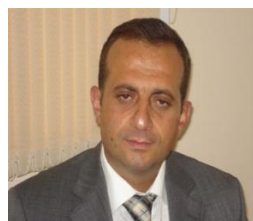

#### **Zohrab ISMAYIL**



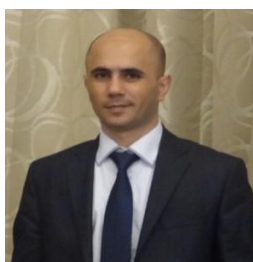
