



How is the current state of your business?






Do you see the decrease in demands for bribes as a result of the steps taken by the government to reduce corruption since the beginning of 2011?






How do you assess the competitive conditions in the sector of the economy that you are working in?



Obtaining a license



Only 20.4% of the surveyed entrepreneurs obtained a license so far. 80.9% of them, in other words, 165 of the respondents said that it was difficult to obtain a license. The main problems were as follows:

- □ Procrastination in the relevant official body that issues license
 30,1%
- Collection of documents from various government agencies to obtain a license
 27,4%,
- ☐ Short duration of a license 18,3%


Real estate registration



222 surveyed entrepreneurs registered their real estates. 78.8% of them noted that it is difficult to register a property. The main problems were as follows:


- □ Procrastination in the relevant official body that issues license
 47,7%
- □ Collection of documents from various government agencies to obtain a license 43,7%
- Rules are ambiguous and not clear 8,3%

The National Fund for Entrepreneurship Support




20% of respondents told that they had applied for loans, for the National

Entrepreneurship Support Fund. 31% of them, or 62 entrepreneurs had been able to get a loan from the fund.




Do you consider yourself protected from the arbitrariness of officials?



What is the reason for not using e-tax payment?


- □ For me, it is hard work, I do not have experience working with electronic system 34,3%

- •10.8% of the surveyed entrepreneurs, 108 respondents said that they are currently engaged in foreign trade operations.
- 4.8% of the respondents, 48 entrepreneurs said that they closed their company in the past.
- 27.2% of respondents, 272 entrepreneurs said that, they had to get permission to carry out construction.

Awareness of legislation



48% of surveyed entrepreneurs can get timely information on decisions of governmental bodies on entrepreneurial issues. This information can be obtained as follows:

• From TVs 66%

During inspections 16,9%

From fellow entrepreneurs 9,2%

From web-sites of governmental bodies 6,6%

• From newspapers 1,3%






If you are oppressed by any local department of a state agency or an official, where you prefer to address?




Azerbaijan is preparing to join the World Trade Organization. Are you aware of it?
